

Southern Seven Health Department, Head Start, and Building Blocks Daycare provides a wide array of services including public health services, early childhood development and child care services for the residents of Alexander, Hardin, Johnson, Massac, Pulaski, Pope and Union counties of Illinois. The purpose of these services is to promote a safe and healthy environment by providing preventative health care, family services and child development programs. Funding for services comes from grants, local property taxes, and fees. The operating budget for fiscal year 2025- 2026 is \$12,093,722. Southern Seven employs 178 full-time employees and 2 part-time employees. Southern 7 Health Department is governed by a 28-member board comprised of elected county commissioner and community members. Southern Seven Head Started is governed by a 30- member policy council consisting of parent and community representatives.

Freedom of Information Act Information

Southern Seven works to maintain transparent processes and open communications with the community. As part of that effort, Southern Seven makes a variety of information available on our website, www.Southern7.org and in our Administrative Office located at 37 Rustic Campus Drive, Ullin, IL 62992. We also work to maintain compliance with the newly updated Illinois Freedom of Information Act, which outlines how public organizations should share information. The Freedom of Information Act does exempt from disclosure some information in possession of the Department. The FOIA officer for Southern Seven is Miranda Adams.

FOIA Request Process: Requests for public records must be made in writing. A request form is available for your convenience. Written requests must be sent to our Administrative Office and addressed to FOIA Officer, Southern Seven Health Department 37 Rustic Campus Dr. Ullin, IL 62992. Requests may also be made via email to foiaofficer@s7hd.org.

The Illinois FOIA does allow for the assessment of fees as follows: No fees shall be charged for the first 50 pages of black and white, letter or legal sized copies. After the first 50 pages, the fee for black and white, letter or legal sized copies shall be 15¢ per page. Actual cost will be charge for other documents not standard size and for electronic recording medium (compact disk, tape, DVD, flash drive). Fees may be waived or reduced if the requestor states the specific purpose for the request and indicates that a waiver or reduction of fees is in the public interest.
